- 4.1. The bidders who are desire to participate in e-procurement shall submit their Technical bids, financial bids etc. in the standard formats prescribed in the Technical documents, published at https://eprocure.gov.in/. - 8.3. Any legal dispute arising out of this contract should be dealt by Courts having jurisdiction at Kochi.

- 13.1. The schedules of delivery as per Purchase Order should be strictly adhered to. In case there is delay in the delivery of items, the firm will be liable to pay the liquidated damages @ 1% of the total value of the item per day.


