Scope of Work

The successful bidder shall submit 10 % of the contract value as Performance guarantee within 7 days from the award of contract. The performance guarantee will be released 60 days from completion of defect liability period (ONE YEAR) without interest.

In case the performance guarantee is not submitted within that time MPEDA shall reject the tender.
