- 2. The envelope should contain;

- 3. The EMD in the form of DD for **Rs.8**, **000/-** (**Rupees Eight Thousand Only**) in the name of the Secretary, MPEDA payable at Ernakulam, shall be submitted in original in a sealed envelope before due date of Tender.
