6. Candidates should upload a valid certificate as per GoI guidelines in proof of their SC/ST community status.

7. MPEDA reserves the right to not fill up the position or cancel the advertisement in whole or in part without assigning any reason and its decision in this regard will be final and binding. MPEDA also reserves the right to extend the closing date for receipt of applications.
8. Candidates will be shortlisted for the selection process on the basis of the information furnished by them in their online application. They must ensure that such information is true. If at any subsequent stage or at the time of test/interview, any information given by them or any claim made by them in their online application is found to be false, their candidature will be liable to be rejected.
