NOTIFICATION

NEW DELHI, dated May, 2025

G.S.R. NO.....In exercise of the powers conferred by Section 33 of the Marine Products Export Development Authority Act, 1972 (Act 13 of 1972), the Central Government hereby makes the following rules further to amend the Marine Products Export Development Authority Rules, 1972, namely:

1. (1) This Rule may be called the Marine Products Export Development Authority (Amendment) Rules, 2025.
- (2) This amendment shall be deemed to have come into force with effect from the date of their publication in the Official Gazette.

2. In the said rules, in sub-rule (1) of rule 33, the following shall be substituted: -

“(1) Every application for the registration of a fishing vessel, processing plant, storage premises for marine products, or conveyance used for the transport of marine products, peeling shed, fresh, chilled, live or dried fish handling centre, **independent / common ice plant, other (edible) marine products or other (non – edible) marine products handling centre** shall be made to the Secretary or other officer authorised by him in Form I, Form II, Form III, Form IV, Form II a, Form II b, Form II c , Form II d, **Form II e, Form II f & Form II g**, as the case may be. Form I may be **obtained online by payment of rupees hundred only & the other forms may be obtained online, on payment of rupees two hundred for each application.**”

3. In the said rules, in sub-rule (2) of rule 33, the following shall be substituted: -

“(2) Every application under sub rule (1) shall be accompanied by the fees specified in the following table:

“(3) Where the application for registration is not refused, a certificate of registration shall be granted in Form V, Form VI, Form VII, Form VIII, Form VI a, VI b, VI c, VI d, VI e, VI f or VI g, as the case may be, and shall be subject to the terms and condition specified in the respective certificate”.

5. In the said rules, in the Title and sub-rule (1) of Rule 38, for, the following shall be substituted:

38. Transfer of ownership of registered entities:

“(1) Where an entity registered under Rule 33 is transferred by way of sale, mortgage or other -wise, the transferee shall within a period of one month from the date of such transfer apply to the Secretary or other officer authorized by him for registering the transfer along with the document evidencing such transfer.”

6. In the said rules, in rule 39, in sub rule (1), the following shall be substituted: -

“(1) If during the period when the entities registration under Rule 33 is in force, the owner thereof desires to change place where the entity is located, or the layout as approved by the Authority, or any change in its capacity or otherwise, or change the place of operation of the fishing vessel or conveyance, he shall apply to the Secretary or other officer authorized by him at least thirty days in advance of such intended change”.

7. In the said rules, in rule 41, after sub-rule (1), the following shall be inserted;

“(1A) Every application for registration as a dealer of marine products (other than an exporter) shall be made to the Secretary or other officer authorised by him in form XI available online on payment of fees of rupees two hundred only and shall be accompanied by a certificate regarding the financial status from any scheduled bank”.

8. In the said rules, in rule 41, for sub-rule (2), the following shall be substituted.

“(2) Every application for registration under Sub-rules (1) and (1A) shall also be accompanied by a fee of rupees five thousand only”.

9. In the said rules, in rule 42, for sub- rule (3), the following shall be substituted -

“(3) Where the application for registration is not refused, the Secretary or other officer shall grant the applicant a certificate of registration in Form X & Form XII, as the case

may be, which shall be subject to such conditions as are mentioned in the certificate thereof”.

10. In the said rules, in rule 43, the existing rule shall be numbered as Sub-rule (1) and the following shall be inserted as sub-rule (2) –

(2) Where the Secretary or other officer is satisfied that any person has obtained a certificate of registration in Form XII, by furnishing incorrect information or that he has contravened any of the provisions of this rule or of conditions mentioned in the certificate of registration, if the secretary or other officer is satisfied that such person has become disqualified to continue as a dealer, the Secretary or such officer may, after giving the person who holds a certificate reasonable opportunity of making his objections, by order cancel the registration and communicate to him copy of such order”.

11. In the said rules, for rule 45, the following shall be substituted –

1. In case any change in the layout, design or capacity is required, the owner should get it approved by the Authority.
2. The owner should comply with the regulations or any other instructions, in respect of handling, processing, packaging, preservation, storage and export of the Other (Edible) marine products, issued by the Authority, from time to time.
3. The owner should use only the approved and food grade chemicals/ preservatives/ additives, if any required, while processing and packaging the products.
4. No chemical, detergent or repellent should be kept or stored in the processing /packing area of this establishment.
5. This establishment and its premises should be kept neat and tidy, sanitarily, and hygienically.
6. The owner should maintain this establishment always conforming to the standards prescribed or adopted by the Authority.
