Sub: Filling up the post of Accounts Officer on deputation basis in the Marine Products Export Development Authority (MPEDA)- reg.

The Marine Products Export Development Authority (MPEDA), a Statutory Body under the Department of Commerce, Ministry of Commerce & Industry, Government of India propose to fill up a post of Accounts Officer, Group 'B' in the Pay Matrix Level 7 as per 7<sup>th</sup> CPC (Prerevised Pay Band PB-2 ₹9300 - 34800 plus GP ₹4600/-) on deputation basis. The pay and allowances and other terms of deputation of the officer selected for the said post will be regulated in accordance with the instructions of the Department of Personnel and Training (DoPT) from time to time.

The qualification and experience required for the post are indicated in Annexure- I.

It is requested that applications of eligible and willing officers, who could be relieved in the event of selection, in the enclosed proforma (Annexure-II) along with the following documents may be forwarded to The Secretary, The Marine Products Export Development Authority, MPEDA House, Panampilly Nagar, Kochi -682 036, Kerala within thirty days from the date of its publication in Employment news.

- i. Photocopy of complete and up-to-date attested Annual Performance Appraisal Reports for the last 5 years, attested by an officer not below the rank of Under Secretary or equivalent.

- iii. Details of minor or major penalties imposed during the last 10 years. (If no penalties have been imposed, it should be stated).
- iv. Vigilance Clearance

Applications received after the last date or without the Annual Performance Appraisal Reports and other relevant documents or otherwise found incomplete will not be considered. The appointment will be on deputation basis. The deputation shall be for a period of three years. The selected officer will have the option to draw the pay of the deputation post or his/her pay plus deputation allowance, in accordance with the existing rules.
