Sub: Filling up the post of System Analyst on deputation basis in the Marine Products Export Development Authority (MPEDA)- reg.

The Marine Products Export Development Authority (MPEDA), a Statutory Body under the Department of Commerce, Ministry of Commerce & Industry, Government of India propose to fill up a post of System Analyst, Group 'A' in the Pay Matrix Level 10 as per 7th CPC (Pre-revised Pay Band PB-3 ₹15600- 39100 plus GP ₹5400/-) on deputation basis. The pay and allowances and other terms of deputation of the officer selected for the said post will be regulated in accordance with the instructions of the Department of Personnel and Training (DoPT) from time to time.

The qualification and experience required for the post are indicated in Annexure- I.
